CALL TO ARMS! PRESERVATION MARCH FROM FT. LAURENS TO ZOAR VILLAGE ALONG THE OHIO-ERIE CANAL TOW PATH.

Zoar, Ohio - A preservation march from Ft. Laurens to the Village of Zoar is planned for Sunday, September 20, 2009. A three mile march will comprise both Confederate and Union reenactors who are interested in helping the Zoar Community Association in their efforts to take over management of the 10-building once operated by the Ohio Historical Society. Due to decreased funding from the State of Ohio, Zoar and 17 other sites are scheduled to close starting July 1st. The Zoar Community Association plans to manage the site and reopen the 10-building to the public.

Each reenactor must raise at least \$20 to participate in the preservation march. The proceeds raised will be used to help the Zoar Community Association preserve the historic building and keep the doors open to tourism here in Zoar.

Pre-registration is required. Soldiers will be bussed to Ft. Laurens Sunday morning at 7:30 am. The march will step off at 8:00 am and end at the restored steel bridge near the Inn on the River.

The program is sponsored by the Zoar Community Association and hosted by the 51st Ohio Volunteer Infantry, Co. B., Inc. and the 6th Ohio Volunteer Cavalry, Co. B., Inc.

Zoar is located on State Route 212, 3 miles southeast of Exit 93 off I-77, 20 minutes south of Canton.
